PURE SAFE AND NUTRITIOUS MILK

India is a leading country in production of milk, contributing to 17% of **world** milk production. Average year-on-year **growth** rate of milk is 4.04% vis-a-vis world average of 2.2% which indicates sustained growth in availability of milk and milk products for growing population. Average yield rate for milk is 7.02 kg/day for cross bred cows, 2.36 kg/day for indigenous cows and 4.80 kg/day for buffaloes (2012-13). However, in terms of milk productivity per animal and the bacteriology of milk, status is far from satisfactory.

Milk is a highly nutritious food, often considered to be a 'Complete food' possessing a treasure of vital constituents like protein, carbohydrate, fat, vitamins and minerals. Milk when produced from an animal is pure and safe. However, upon subsequent handling of milk (milking, storage, transportation, chilling) there are chances of milk becoming unsafe owing to contamination with pathogens. Milk produced having traces of antibiotics and heavy metals is also considered to be unsafe. Unscrupulous activities by the milk traders such as adulteration of milk not only reduce the nutritive value of milk, but can make it unsafe too.

Checking for adulterants at the reception dock of village cooperative society and at the dairy plant can restrict entry of milk with **adulterants**. There is need to **develop** equipments that can not only precisely identify the type of adulterant, but also quantify them in case of need (i.e. legal matters). Taking due care of milk during its handling prior to processing and judicious processing of milk (HTST/UHT) can render safety of the raw milk procured. Newer **non-thermal processes** such as High pressure processing, Pulsed Electric Field, Ultrasonication, etc. are being adopted worldwide for preserving the **native nutrients** as well as flavor, post processing.

Looking to the **health consciousness** of today's consumers, low-fat milk, reduced fat milk in order to reduce calorie and cholesterol are being catered to by the dairy industry. In this context, there is paucity of **fat soluble vitamins** which are essential for bodily functions. Hence, development of **'Vitaminized milks'** (especially Vitamin A and D) is the necessity. Fruit juices are potent in **vitamin C** and certain phytochemicals. Combining milk and fruit juices would further enhance the nutritive value of the beverage. The requirement of **protein** is high for children and **geriatrics**. In this regard, **membrane processing** of milk (i.e. Ultrafiltration) helps in raising the protein content of the resultant milk (i.e. retentate) which can be targeted at such needy populace.

The dairy industry in India also has to look into the **allergenicity of milk** to susceptible individuals or group of people. These include lactose intolerance, allergenicity to -lactoglobulin, etc. Value addition of milk can be done through addition of edible dietary fibers, minerals like iron, calcium, fluoride or even phytonutrients and increasing its **therapeutic value** through increasing the **Conjugated linoleic acid (CLA)** content of milk.
