**Revised Rules and Regulations Governing Games, Sports Tournaments, Cultural, Literary Competitions for Intercollege/ Inter polytechnic/Interuniversity and Adventure Activities of Anand Agricultural University, Anand**

In exercise of the power vested in Section 22(2) (xiv and xv) of the Gujarat Agricultural Universities Act, 2004 (Gujarat Act No. 5 of 2004) the Board of Management approved the following regulations namely "Revised Rules and Regulations governing Games, Sports Tournaments, Cultural, Literary Competitions for Intercollege/Inter polytechnic/Interuniversity and Adventure Activities" of Anand Agricultural University recommended by the Academic Council

<b>1.</b>	<b>Title of the Rules</b> Rules and Regulations governing Games, Sports Tournaments, Cultural, Literary Competitions for Intercollege/Inter polytechnic/Interuniversity and Adventure Activities of Anand Agricultural University
<b>1.1</b>	The rules shall come into force from the date of notification by superseding all previous rules.
<b>2.</b>	<b>Definition</b>
<b>2.1</b>	In these rules, unless the context otherwise requires, <b>Sports</b> means an activity that is governed by a set of rules or customs and often engaged in competitively. Sports commonly refers to activities where the physical capabilities of the competitor are the sole or primary determinant of the outcome (winning or losing), but the term is also used to include activities such as mind sports and motor sports where mental acuity or equipment quality are major factors. Sports is commonly defined as an organized, competitive and skillful physical activity requiring commitment and fair play.
<b>2.2</b>	<b>Player/participant</b> means one that plays/performs, especially one who participates in Games, Sports Tournaments, Cultural, Literary Competitions and Adventure Activities of Anand Agricultural University.
<b>2.3</b>	<b>Tournament</b> means a sporting competition in which contestants play a series of games to determine an overall winner.
<b>2.4</b>	<b>Intercollege/Inter polytechnic</b> means competition taking place among different colleges/polytechnics of Anand Agricultural University.
<b>2.5</b>	<b>Interuniversity</b> means competition taking place among different universities of the state or the country.
<b>2.6</b>	<b>College</b> means a constituent college conducting degree or polytechnic programme in Anand Agricultural University.
<b>2.7</b>	<b>Sports Committee</b> means a committee of the Student Sports and Recreation. The Committee has to develop and implement strategies and policies to develop, encourage and coordinate sports activities across the institute.
<b>2.8</b>	<b>Referee/Judge</b> means a person who has authority to make decisions about sports/performances in tournaments/competitions.
<b>2.9</b>	<b>Competition</b> means an official participation in an organized sport.
<b>2.10</b>	<b>Team</b> means a number of persons associated together in any sports; especially, a number of persons selected to contend on one side in a match, or a series of matches. Note: Words and expressions used in these rules and not defined in these rules have the same meaning assigned to them in the GAU Act. 2004.

3.	<p><b>Sports Committee</b></p> <p>There shall be a committee consisting of the following to organize, control, manage and supervise various tournaments/competitions and students' welfare programmes within the jurisdiction of the university and conduct Intercollege/Inter polytechnic/Interuniversity sports tournaments/competitions.</p> <p>i. Director of Students' Welfare - Chairman  ii. Chairman of SRC of all the constituent colleges - Member  iii. Physical Instructors of all the constituent Colleges – Member</p>
4.	<p><b>Power/Functions of the Sports Committee</b></p> <p>The powers and functions of the Sports Committee shall be as follows:</p> <p>(i) To prepare its programme calendar of various games, sports, cultural and literary events, adventure programmes and its budget for presentation to the university.</p> <p>(ii) To decide that university should participate in the several Interuniversity games and sports tournaments, cultural, literary competitions.</p> <p>(iii) To appoint sub-committee, if necessary, to select university team and to conduct Intercollege/Inter polytechnic/Interuniversity games and sports tournaments, cultural, literary competitions whenever the university is asked to do so by the Association of Indian Universities (AIU), Inter Agricultural Universities Association (IAUA), Indian Council of Agricultural Research (ICAR) or Council of State Agricultural Universities of Gujarat.</p> <p>(iv) To frame eligibility rules and general rules for games and sports, cultural and literary competitions and other adventure activities.</p> <p>(v) To settle dispute if any, among constituent colleges/polytechnics with regard to tournaments/competitions and other student activities within the jurisdiction of the sports committee.</p> <p>(vi) To take up such other programmes and activities within the jurisdiction of the sports committee as desired for the welfare of the students.</p>
5.	<p><b>Intercollege/Inter polytechnic Games and Sports Tournaments</b></p>
5.1	<p>The method of the various tournaments shall be decided by the committee.</p>
5.2	<p>All the colleges/polytechnics shall inform the organizing college/polytechnic regarding their participation and shall submit two copies of eligibility pro forma of the players before the commencement of the tournaments.</p>
5.3	<p>A lot of the tournaments will be drawn in presence of all team managers and Organizing Secretary.</p>
5.4	<p>The Sports Committee shall allocate the responsibility to conduct the tournament to any constituent college.</p>
5.5	<p>The organizing college/polytechnic shall be responsible for organization, supervision and conduct of the tournament. If required, the Principal of the organizing college/polytechnic shall appoint various committees. The Chairman, Students' Representative Council shall be the Organizing Secretary. However, the overall responsibility of organizing the tournament shall be of the Director of Students' Welfare and he/she may delegate his/her power to anyone to whom he/she deems fit wishes to. The Organizing Secretary shall draw the detailed programme of the Intercollege/Inter polytechnic tournament and send it to all participating colleges/polytechnics under intimation to the Chairman, Sports Committee.</p>

5.6	<p>It shall be the duty of organizing committee to ensure that all the rules and regulations laid down by the Sports Committee for the Intercollege/Inter polytechnic tournament are fully observed and game/tournament is played fairly. In case, where a particular team has included ineligible player, as defined in the rules, the team shall be disqualified from the tournament after due verification. In case of the misconduct by any individual player(s) or a team as a whole, the organizing committee shall have power even to scratch the team/disqualify the individual player(s) from the tournament. While doing so, whoever, the organizing committee shall strictly follow the procedure as laid down below:</p> <p>(a) Both the teams under dispute are given full opportunities to explain their respective points of view.</p> <p>(b) The Principal of the organizing college/polytechnic shall constitute the committee of (i) Organizing Secretary (ii) Physical Instructor (iii) One expert of the game</p> <p>(c) The matter is reported immediately to the Chairman, Sports Committee for information and further action if any.</p>																																																																						
5.7	<p>The Organizing Secretary and Physical Instructor in consultation shall be empowered to select/appoint the competent referee/official/judge for the tournament.</p>																																																																						
5.8	<p>It shall be duty of the Organizing Secretary to inform the Chairman, Sports Committee regarding the date of tournament/competition. The result of the tournament along with eligibility pro forma and a list of the selected players of the university team shall be submitted to the Chairman, Sports Committee. The result shall also be sent to all colleges/polytechnics on the next day.</p>																																																																						
5.9	<p>Each constituent college/polytechnic shall be entitled to send only one team for each tournament.</p>																																																																						
5.10	<p>There shall be no entry fees for participation in Intercollege/Inter polytechnic tournament.</p>																																																																						
5.11	<p>Each participating college/polytechnic shall send necessary information relating to tournament/competition to the Organizing Secretary in time prescribed by the Sports Committee.</p>																																																																						
5.12	<p>Eligibility rules for participants</p> <p>i. As per rules prescribed by the AIU/IAUA/ICAR from time to time.</p> <p>ii. A student shall not compete on behalf of more than one college/polytechnic in any Intercollege/Inter polytechnic tournament in a year.</p>

- 5.14** (a) In Athletics, no student can participate in more than five events excluding relay races for Individual General Championship.
- (b) Men player can participate in any 5 events (2 running events and 3 field events or 3 running events and 2 field events, relay race shall not be considered). Women player can participate in any 3 events (2 running event and 1 field event or 1 running event and 2 field events, relay race shall not be considered).
- (c) There shall be a separate General Championship for men and women players of the university. Minimum 3 players shall take part in the Individual General Championship.
- (d) The Sports Committee is empowered to add or delete any Athletic event for men and women.
- (e) Following Athletic events shall be played for Intercollege/Inter polytechnic Athletic competition:

Note: (i) For the Intercollege/Inter polytechnic meet, each college/polytechnic may send maximum two competitors for each Athletic event and one team for relay race, the total competitors, however not to exceed 15 in men and 10 in women.

(ii) In individual event, if there are less than three competitors, the competition of that event shall not be organized.

- 5.15** All athletes and competitors participating in Intercollege/Inter polytechnic tournament shall carry with them identity cards signed by the principal of the college concerned.

- 5.16** The player's uniform for different games shall be as follows:

- 5.17** If the match is not played due to any valid reasons like rain etc., it shall be played as per the rules of a particular game.

- 5.18** Protest against the decision of referee/umpire/judge or any other matter shall be lodged in writing within two hours of conclusion of the game/competition by depositing Rs.1000/- to the Organizing Secretary of the college/polytechnic.

- 5.19** If the protest is lodged prior to or during match, the match shall be played out. Teams which abandon a match for any reason shall be considered to have concerned it. Any team leaving field of play under protest shall be deemed to have loss the fixture and forfeited whenever a protest is not sustained. The Organizing Secretary shall send a report of any such incident to the Chairman, Sports Committee.

5.20	(i) The organizing college/polytechnic shall arrange for the trophies from university funds/college funds/donations and those shall be the property of the winner/runners up college/polytechnic. (ii) Trophies shall be awarded to the Winner and Runners up colleges/polytechnics.																																										
5.21	A certificate of merit shall be awarded to all the players of the winning team in team games and solo game securing first, second and third places.

5.23	The Annual Athletic Meet shall be the last function of the Intercollege/Inter polytechnic tournament of the year, wherein trophies, medals, certificates etc. shall be awarded to individual winners and winning teams. The captains of winning teams of different games shall remain present to receive trophies, medals, certificates etc. and they are entitled for TA and DA as per the rules.																																										
5.24	<p>(i) The university shall bear expenses on account of refreshment, official charges, ground preparation, hiring of grounds and such other items pertaining to pay-fields etc. as per the budget provision.</p> <p>(ii) The university shall bear total cost of the second-class rail/bus fare with reservation charges of players other than local players from the place of the college/polytechnic to the place of tournament and back, if transportation arrangement is made by the college/polytechnic, the university shall bear the total diesel/oil expenditure etc.</p> <p>(iii) The university shall bear total cost of the DA of players/participants.</p> <p>(a) The players/participants of out-station college/polytechnic shall be paid DA at the rate of Rs.200/- per day.</p> <p>(b) The players/participants of local college/polytechnic shall be paid the refreshment/ convenience allowance at the rate of Rs.100/- per day. If the tournament is conducted during the vacation, the players/participants shall be entitled to get TA and DA from the place of native to the place of tournament and back at the rate shown in (a) and (b) earlier.</p> <p>(iv) The university shall bear the expenses of the officials of various tournaments/competitions as per <b>Appendix</b></p>

<b>6.</b>	<b>Interuniversity Tournaments/Competitions</b>
<b>6.1</b>	The university may participate in the Interuniversity tournaments/competitions, Yuva Mahotsav, Khel Mahakumbh, West Zone/ICAR/AIU tournaments/competitions etc. as may be decided by the Sports Committee.
<b>6.2</b>	The selection of the university team or participants shall be made on the basis of performance in the Intercollege tournaments/competitions.
<b>6.3</b>	The selection committee for the selection of university team shall include (i) Physical Instructor/s (ii) Chief Referees/Judges. If the teams/participants are not selected by selection committee, the Chairman, Sports Committee is empowered to select the same to represent the university.
<b>6.4</b>	The Chairman, Sports Committee shall assign the duty of team manager to any staff member who will be overall responsible for the participation in the tournament/competition.
<b>6.5</b>	The annual subscription for the membership of the concerned association shall be paid by the university every year.
<b>6.6</b>	The university shall bear the cost of Rs. 800/- per participant as dress allowance for each tournament.
<b>6.7</b>	(i) The university shall bear the maximum cost of Rs. 2500/- for track-suit/blazer for all the participants. The track-suit/blazer shall be given to the player only once in one degree programme at the university. (ii) The university shall bear the maximum cost of Rs. 2500/- for track-suit/blazer for the Team Manager with an interval of 3 years.
<b>6.8</b>	The university shall bear the second-class railway fare with reservation charges/state or private bus traveling charges, diesel, oil, toll taxes, other expenses of the university vehicles etc.
<b>6.9</b>	The participants are entitled to get DA at the rate of Rs. 400/- per day for the tournament/competition conducted outside the state and Rs.250/- per day for the tournament/competition conducted within the state. The refreshment/convenience allowance of Rs.200/- per day shall be paid to the participant where lodging and boarding facilities are provided by the organizer.
<b>6.10</b>	The university shall provide TA and DA to the player/participant for coaching camp as per rates of the Intercollege/Inter polytechnic tournament/competition.
<b>6.11</b>	The university shall provide the equipment, ground facility etc. required for coaching camp.
<b>6.12</b>	The university shall bear the cost of officiating charges, equipment charges or other charges of the tournaments/competitions.
<b>6.13</b>	The university may appoint a coach for advance training to the university team. The coach shall be entitled to get TA and DA as well as remuneration as per rules for the officials of Intercollege/Inter polytechnic tournament/competition.
<b>6.14</b>	The university shall bear petty expenditure for refreshing item such as glucose, lemon, ice-cream, biscuit, fruit etc.
<b>6.15</b>	In case of sickness or physical injury to the player/participant during the actual game/competition/coaching camp at the time of Inter college/Inter polytechnic/Inter university/All India competition, the cost of medical treatment of the player/participant shall be borne by the college/university.
<b>6.16</b>	Any point not directly covered in the rules shall be decided by the Sports Committee in the light of the rules most nearly applicable and in the accordance with the general tenor/tendency and spirit of the said rules. During the interpretation of the same rules at any time, the decision of the Director of Students' Welfare shall be final.

<b>7.</b>	<b>Intercollege Cultural Competitions</b>																												
<b>7.1</b>	Any student enrolled in the constituent college of the university shall be eligible to participate in the competitions. The eligibility rules for the competitions shall be same as the rules for the Intercollege Sports and Games Tournaments.																												
<b>7.2</b>	Each college shall send one entry for Patriotic Group Song, Folk Dance, One Act Play, Mime Skit and Mono Acting.																												
<b>7.3</b>	Total number of participants from a college shall not be more than 30 for Literary and Cultural Competitions excluding accompanists.

<b>7.8</b>	The expenditure for refreshment, remuneration, stage preparation, trophies, certificates etc. shall be paid from the university fund allotted for the purpose.																												
<b>7.9</b>	Overall aggregate score of judging committee shall be considered to decide the individual winner and winning college for each competition separately.																												
<b>7.10</b>	The decision of judging committee shall be final and binding to all.																												
<b>7.11</b>	A certificate to every winner and trophy to winning college shall be awarded. The prizes shall be awarded to first and second winner.

<b>8.2</b>	The organizing college has to decide the topic and announce it prior to seven days of the Debate and Essay competition.
<b>8.3</b>	The expenditure for refreshment, remuneration, trophies, certificates etc. shall be paid from the university fund allotted for the purpose.
<b>8.4</b>	The participants shall be entitled to get TA and DA as per the rules of Intercollege Sports and Games Tournaments.
<b>8.5</b>	The judges for the competition shall be appointed by the organizing college. The judges shall be entitled to get TA and DA as per rates of the Intercollege Sports and Games Tournaments and shall be paid remuneration as per the rates mentioned in the <b>Appendix</b> .
<b>8.6</b>	Overall aggregate score of judging committee shall be considered to find out the winners.
<b>8.7</b>	The decision of the judging committee shall be final and binding to all.
<b>8.8</b>	The trophy and certificate shall be awarded to the first and second (Favour & Against) winner in Debate competition and first and second winner in Extempore competition and Essay competition.

#### Debate

1. Medium of expression shall be English or Hindi or Gujarati.
2. Any form of written matter as aid shall not be allowed. Violation shall be liable for disqualification.
3. Judgment will be based on qualities like coverage, language, diction and general impression etc.

#### Extempore

1. Topic for extempore shall be put in a 'fish pond' from which the participant shall pick.
2. Each participant shall be given five minutes for preparation after picking up the topic and maximum of five minutes for presentation.
3. Medium of expression shall be English or Hindi or Gujarati.
4. Judgment will be based on qualities like coverage, language, diction, presence of mind, relevance to the topic, general impression etc.

#### Essay Writing

1. The word limit for Essay writing is 3000 words.
2. There must be at least six essays for the competition.
3. Medium of expression shall be English or Hindi or Gujarati.
4. There shall be a separate Essay competition for UG and PG students.
5. Judgement will be based on Content (relevance to the theme, comprehensiveness, originality, insights), Organization (clarity of thoughts, creativity, unity and consistency), Mechanics (punctuation, spelling, capitalization, grammar) etc.

#### 9. Adventure Activities

- 9.1 The students of constituent colleges may take part in the activities.
- 9.2 The selected students shall be entitled to get bus/second class railway fare from college to the place of camp and back.
- 9.3 The students shall be paid DA as per rules of Interuniversity tournament/competition.
- 9.4 If the lodging and boarding arrangements are made by the organizer, the total cost of the expenditure shall be borne by the university.
- 9.5 The selection of the candidate will be made on the basis of seats available and selection criteria of adventure activities.
- 9.6 A team manager shall be appointed to look after the administrative and account matter.
- 9.7 The adventure programmes which are approved or conducted by the government agencies shall be undertaken.
