

Sub: Merging of AICRP on NSP (Crops) & ICAR Seed Project into single entity 'AICRP on Seed (Crops)' and nomination of Nodal Officer under the rechristened scheme-thereof-reg.

Sir.

Greetings from ICAR-IISS, Mau!

It is to bring to your kind contemplation that, as per the recommendations of 'Review Committee on AlCRPs' constituted by ICAR, two ongoing network schemes i.e. AlCRP-NSP (Grops) and ICAR Seed Project. Seed Production in Agricultural Grops' have been merged and reorganized as 'AlCRP on Seed (Grops)' with two components viz. Quality Seed Production (QSP) and Seed Technology Research (STR). The new revised scheme 'AlCRP on Seed (Crops)' is already part of current EFC and this arrangement will come into force with the final approval of EFC 2021-26 (likely before Sept., 2021). The breeder seed production component of AlCRP-NSP (Grops) and quality seed production aspect of ICAR Seed Project has been merged together to form 'Quality Seed Production' component under AlCRP on Seed (Crops). Seed Technology Research (STR) component of AlGRP-NSP (Crops) shall be continued as such under AlCRP on Seed (Crops).

During current FY 2021-22, the release of grants for first quarter was done separately for both AICRP-NSP (Crops) and ICAR Seed Project as per the existing arrangements. From second quarter of FY 2021-22, the release of grants shall be made as per the newly proposed scheme i.e. AICRP on Seed (Crops) as communicated from ICAR. Hencefords release of grants shall be under two components i.e. 'Quality Seed Production' and 'Seed Technology Research' only. Further, for the purpose of accounting and submission of Utilization Certificate for the current FY, the grants release during first quarter need to be accounted together and UCs may be prepared accordingly.

Further, more importantly, regarding the overall management of the AICRP on Seed (Crops), the QSP component will encompass both breeder seed production & quality seed production programmes and STR component will encompass implementation of alloted experiments as per the technical programme decided during AGMs of referred project. Even though, after several instructions to cooperating centres of referred schemes on various forums, few cooperating centres are not following Single Window System (SWS) for overall management of the project,



Greetings from ICAR-IISS, Mau!

With reference to cited subject, it is clarify that the nature as per our earlier communication vides letter no. DIR/IISS/2020/08-201 dated on 11.08.2021, it is clarify that;

- Both the components of AICRP on Seed Crops need to be treated on the basis of 75:25
 (ICAR: State share)
- Grants released under TSP and SCSP of AlCRP on Seed Crops need to be treated as 100
 per cent funding from IGAR. No question of state comes for TSP and SCSP.
- As ICAR Seed Project is merged with QSP component of AICRP on Seed Grops, it need to be treated on the 75:25 basis only
- The rechristened scheme that is AICRP on seed Crops is already in existence after merger
 of erstwhile AICRP NSP Crops and ICAR Seed Project.

In this regard, for the purpose of accounting and submission of Utilization Certificate for the Financial year (both the components of AICRP), may be prepared accordingly on 75:25 basis (ICAR: State share) only. This is for your information and necessary action.
