ABOUT THE SEMINAR

Livestock and dairying play a vital role in rural economy by supplementing family income and generating gainful employment, particularly to the landless labourers, small and marginal farmers and women, besides providing nutritional security to millions of people. In the livestock sector, major constraints experienced by the farmers are related to breed, feed and fodder, health care and remunerative prices for the produce. In domestic and international markets, the trade of livestock and different livestock products like milk, eggs, meat, fish and their value added products is being influenced by the WTO's agreement on agriculture. Therefore, the policy envisages addressing these issues through an appropriate strategy.

In light of the above, WTO Cell, Department of Agricultural Economics and Department of Animal Science, B. A. College of Agriculture, Anand Agricultural University, Anand is organizing a two days national seminar on "**Prospects of Livestock and Dairying in India under changing Global Economic Era**" on **17th and 18th January 2013**.

CALL FOR PAPERS

The seminar invites research paper for presentation in the technical sessions from the intellectuals, academicians, experts, researchers, students, policy planners and all concerned with livestock and dairy sector. Papers presented at the seminar will only be considered for full length coverage in the Seminar Proceedings which will be brought out by Anand Agricultural University. One copy of the Seminar Volume will be given as gratis to each senior author of the published papers.

SUBMISSION OF PAPERS

Papers covering one or more of above cited themes along with an abstract (About 300 words) may be submitted for consideration. Papers should be neatly typed in double space in MS words on A-4 size papers. Both hard copy and soft copy of the paper should be submitted. The last date for receipt of abstract is 5th December, 2012 and for full paper 10th December 2012. An advance copy of the paper may also be sent through e-mail with an attachment. Communication regarding the acceptance of the papers for presentation at the seminar will be sent to the respective senior author through email.
