- The data collected by the Criteria Heads for NAAC Accreditation was reviewed in detail. Suggestions for refinement and additional inputs were provided. It was emphasized that all required documentation must be finalized before the upcoming submission deadline.
- Plans for celebrating International Yoga Day at Anand Agricultural University were discussed. It was decided to organize a university-wide event involving students, staff, and faculty to promote health and wellness.
- The need for enhanced campus security through the installation of CCTV cameras was deliberated. The locations for installation were identified, and the engineering department was tasked with preparing a feasibility report and timeline for implementation.
- A discussion on the Career Advancement Scheme (CAS) for faculty members was held. Members reviewed the current process and identified areas for improvement.
