Mannari Gold Medal" and approves following Regulations governing the said prize as recommended by the Academic Council.

Regulations governing Dr. M N. Mannari Gold Medal

Name of the prize shall be "Dr. M N. MANNARI GOLD MEDAL" Name 1. The amount of endowment of Rs. 1, 00,000/- received from the donor shall Endowment 2. suitably be invested by the Comptroller in the form of fixed deposit in any nationalized Bank. The annual realization of the endowment shall be credited to the "University Fund". The Medal shall be awarded annually from the annual interest realized. The prize shall be awarded every year to a student of B.V.Sc. & A.H. Eligibility degree programme, who secures the highest Cumulative Grade Point Average (CGPA.) in the subject of Veterinary Surgery & Radiology up to the end of ninth semester. In case more than one student are found to have secured same CGPA, in such case the highest OGPA at the end of tenth semester shall be considered to determine the awardee. A student shall not be eligible for the above prize if he/she: secures less than 5.0 grade point or secures "F" (Fail) or "US" (Unsatisfactory) or "I" (Incomplete) grade at any time in any course of Veterinary Surgery & Radiology discipline including Quality Assurance course, has dropped (barring withdrawal) any course of Veterinary (vi) Surgery & Radiology discipline as a regular student, discontinued at any time the B.V.Sc.& A.H. degree programme in (vii) between and was punished by the University for breach of any rules, (viii) regulations, discipline during and up to the end of final year examination. The prize shall be awarded in the form of a Gold Medal engraved with the Form of the 5. prize words "DR. M N. MANNARI GOLD MEDAL' The Registrar shall prepare the list of students pursuing the course of Procedure 6. B.V.Sc. & A.H. of Anand Agricultural University who fulfill the condition mentioned in 4 (1) & 4 (2) above and shall present the same to the committee constituted to decide the awardee.
