APPENDIX-A

In exercise of the power vested in Section 20(1) (xxv) of the Gujarat Agricultural Universities Act, 2004 (Gujarat Act No. 5 of 2004) the Board of Management here by institutes a medal in the name of "IXth ISVPT-Anand Medal in Veterinary Pharmacology & Toxicology" and approves following Regulations governing the said prize as recommended by the Academic Council.

Regulations governing "IXth ISVPT-Anand Medal in Veterinary Pharmacology & Toxicology"

- Name of the medal shall be "IX" ISVPT-Anand Medal in Veterinary 1. Pharmacology & Toxicology"
- The amount of endowment of Rs. 50,000/- received from the donor shall 2. suitably be invested by the Comptroller in the form of fixed deposit in any nationalized Bank.

Endown

- The annual realization of the endowment shall be credited to the "University 3. Fund". The Medal shall be awarded annually from the annual interest realized.
 - The medal shall be awarded every year to a student of B.V.Sc. & A.H. degree programme, who secures the highest Cumulative Grade Point Average (CGPA.) in the subject of Veterinary Pharmacology & Toxicology up to the end of ninth semester. In case more than one student are found to have secured same CGPA, in such case the highest OGPA at the end of tenth semester shall be considered to determine the awardee.

Eligibilit

A student shall not be eligible for the above prize if he/she:

4.

- secures less than 5.0 grade point or secures "F" (Fail) or "US" (Unsatisfactory) or "I" (Incomplete) grade at any time in any course of Veterinary Pharmacology & Toxicology discipline.
- has dropped (barring withdrawal) any course of Veterinary (ii) Pharmacology & Toxicology discipline as a regular student,
- (iii) discontinued at any time the B.V.Sc.& A.H. degree programme in between and
- was punished by the University for breach of any rules, (iv) regulations, discipline during and up to the end of final year examination.

5. The medal shall be awarded in the form of a Medal engraved with the words "Vet. Pharmacology & Toxicology Medal" 6.

Form of i medal Procedure

- The Registrar shall prepare the list of students pursuing the course of B.V.Sc. & A.H. of Anand Agricultural University who fulfill the condition mentioned in 4 (1) & 4 (2) above and shall present the same to the committee constituted to decide the awardee.
- Following committee shall decide the awardee for the "IXth ISVPT-Anand Medal in Veterinary Pharmacology & Toxicology"
