Eligibility 4. degree programme, who secures the highest Cumulative Grade Point Average (CGPA) in the subjects of Veterinary Pathology, Microbiology and Parasitology of B.V.Sc & A.H. up to the end of sixth semester. In case more than one student are found to have secured same CGPA, in such case the highest OGPA at the end of ninth semester shall be considered to determine the awardee. A student shall not be eligible for the above prize if he/she: secures less than 5.0 grade point or secures "F" (Fail) or "US" (Unsatisfactory) or "I" (Incomplete) grade at any course of Veterinary Pathology, Microbiology and Parasitology of B.V.Sc. & A.H. including Quality Assurance course, has dropped (barring withdrawal) any course of Veterinary (ii) discipline as a regular student, discontinued at any time the B.V.Sc.& A.H. degree programme in (iii) between and was punished by the University for breach of any rules, (iv) regulations, discipline during and up to the end of final year examination.
