In exercise of the power vested in Section 20(1) (xxv) of the Gujarat Agricultural Universities Act, 2004 (Gujarat Act No. 5 of 2004) the Board of Management hereby institutes a prize in the name of "V. C. Desai Charities Medal" and approves following Regulations governing the said prize as recommended by the Academic Council.

Regulations governing V. C. Desai Charities Medal

1.	Name of the prize shall be "V.C.DESAI CHARITIES MEDAL"	Name
2.	The amount of endowment of Rs. 25,000/- received from the donor shall suitably be invested by the Comptroller in the form of fixed deposit in any nationalized Bank.	Endowment
3.	The annual realization of the endowment shall be credited to the "University Fund". The Medal shall be awarded annually from the annual interest realized.	
4.	<p>(1) The prize shall be awarded every year to a student of B.V.Sc. & A.H. degree programme, who secures the highest Overall Grade Point Average (OGPA.) after completion of X semesters of B.V.Sc. & A.H. In case more than one student are found to have secured same OGPA, in such case the highest overall grade point average in the subjects of Animal Science (Animal Genetics & Breeding Animal Nutrition Live Stock Production and Management) at the end of ninth semester of B.V.Sc. & A.H. degree will be considered to determine the awardee.</p> <p>(2) A student shall not be eligible for the above prize if he/she:</p> <ul style="list-style-type: none"> (i) secures less than 5.0 grade point or secures "F" (Fail) or "US" (Unsatisfactory) or "I" (Incomplete) grade at any course of Veterinary discipline including Quality Assurance course, (ii) has dropped (barring withdrawal) any course of Veterinary discipline as a regular student, (iii) discontinued at any time the B.V.Sc.& A.H. degree programme in between and (iv) was punished by the University for breach of any rules, regulations, discipline during and up to the end of final year examination. 5.	The prize shall be awarded in the form of a Gold Plated Silver Medal engraved with the words "V. C. Desai Charities Medal"	Form of the prize
6.	<p>(1) The Registrar shall prepare the list of students pursuing the course of B.V.Sc. & A.H. of Anand Agricultural University who fulfill the condition mentioned in 4 (1) & 4 (2) above and shall present the same to the committee constituted to decide the awardee.</p> <p>(2) Following committee shall decide the awardee for the V. C. Desai Charities Medal:</p> <ul style="list-style-type: none"> (a) Dean, Faculty of Veterinary Science, Anand Agricultural University - Chairman (b) The Director of Students' Welfare, Anand Agricultural University (c) The Registrar, Anand Agricultural University (d) One Trustee of V.
