**Terms and Conditions for awarding Teaching Assistantship**

1. He/She shall not be paid any remuneration for the Teaching Assistantship.
2. At the time of awarding TA, the regular Ph.D. student (applicant) must have completed his/her approved course work of Ph.D. Programme (Except credit seminar).
3. The applicant must give his/her written assurance on forwarding letter that, he/she will strictly abide to rules/regulation regarding Teaching Assistantship at AAU, Anand
4. The selected Teaching Assistant will have to sincerely complete the teaching/practical classes assigned to him by concerned HoD/Course Teacher.
5. Teaching Assistant will avail the leave only under exceptional circumstances and only after prior intimation and approval of the concerned HoD.
6. If he/she leaves the assignment without permission, he/she will not be entitled to get the certificate.
7. He/She shall devote sufficient time to the assignment given to him and shall not be allowed to accept or hold another engagements, paid or otherwise, during that period, except the on-going assignment at AAU with prior permission of concerned Principal Investigator of the project.
8. The candidate will not claim regularization or any other benefits of regularization including pay scale allowances or other benefits of any regular post.
9. He/She shall join the college/department within a week on receipt of the order, failing which the order will stand cancelled.
10. He/She shall not be entitled to claim any TA/DA for the journey to join the duty.
11. He/She will not be allowed to join any other organization, trade, financial benefits from any other scholarship/fellowship except the on-going assignment at AAU, Anand or any other type of business employment etc. during the period of Teaching Assistantship.
12. Under no circumstance, the Evaluation work of courses will be undertaken by Teaching Assistant.
13. The above conditions as amended from time to time by Government /University/ ICAR will be abiding to the candidate.
