ANNEXURE I

In exercise of the power vested in section 20(1) (xxv) of the Gujarat Agricultural University Act, 2004 (Gujarat Act No. 5 of 2004), the board of Management hereby institutes a prize in the name of "Memon Trust Dr. K.M.Munshi Cash Prize" and approves following regulations governing the said prize as recommended by the Academic Council.

Regulations governing "Memon Trust Dr. K.M.Munshi Cash Prize"

1. Name of the prize shall be "Memon Trust Dr. K.M.Munshi Cash Prize"
2. The amount of endowment of ₹. 76594/- received from the Sponsorer Dr. G.N.Memon shall suitably be invested by the Account Officer cum Comptroller in the form of fixed deposit in any Nationalized Bank.
3. The annual realization of the endowment shall be credited to the "University Fund". The prize shall be awarded annually from the annual interest realized.
4. (1) The prize shall be awarded every year to a regular girl student of B. Tech. (Food Technology) programme who secures first class with the maximum Overall Grade Point Average (O.G.P.A.) in B. Tech. (Food Technology) examination of the Anand Agricultural University. In the event of a tie, the awardee shall be selected on the basis of the highest Cumulative Grade Point Average (CGPA) obtained at the end of Eighth Semester of B. Tech. (Food Technology) degree.
(2) A student shall not be eligible for the above Cash Prize if she
 - (a) secures less than 6.5 grade point or score 'F' (fail) or 'US' (Unsatisfactory) or 'I' (incomplete) grade at any time in any of the courses of B.Tech (Food Technology) degree,
 - (b) Has dropped (Barring Withdrawal) any course of B. Tech. (Food Technology) degree programme as a regular student.
 - (c) Discontinued at any time the B. Tech. (Food Technology) degree programme in between and / or
 - (d) Was punished by University for breach of any rules, regulation, and discipline.
5. The prize shall be awarded in the form of a Cash Prize and a certificate with the words "Memon Trust Dr. K.M.Munshi Cash Prize"
6. (1) The Registrar shall prepare the list of girl students pursuing the course of B.Tech (Food Technology) of Anand Agricultural University who fulfill the condition mentioned in 4. (1) & 4 (2) above and shall present the same to the committee constituted to decide the awardee.
(2) Following committee shall decide the awardee for the "Memon Trust Dr. K.M.Munshi Cash Prize"
 - (a) Principal & Dean, Faculty of Food Processing Technology & Bio-Energy, Anand Agricultural University, Anand - **Chairman**
 - (b) Director of Students' Welfare, Anand Agricultural University, Anand
 - (c) Registrar, Anand Agricultural University, Anand
- (3) The decision of the Committee shall be final.
7. (1) The cash prize shall be announced and awarded to the Awardee on the occasion of the Convocation of the University.
(2) The endowment shall suitably be acknowledged by the Anand Agricultural University on the occasion of Convocation of the University.
8. The endowment shall suitably be incorporated in the Annual Report of the Anand Agricultural University, Anand.
