It is hereby notified to all concerned that the 58<sup>th</sup> Meeting of Board of Management held on 27/07/2023 has resolved as under vide item No. 58.31:

"It is resolved that the Board of Management accord approval of revised conditions and implementation of payment of publication charges as mentioned below to be sanctioned to the authors (Scientists/ Teachers) of Anand Agricultural University as recommended by 15<sup>th</sup> Agricultural Research Council vide item No. 15.10"

- Research journal should have NAAS rating 5.00 or above. For basic science and other concerned discipline where NAAS ratings are not available, Impact Factor (Thomson Reuters) 0.05 may be considered.
- 2. Scientist/ Teacher (first author) will be eligible for maximum five publications in a financial year subject to ceiling as specified in point No. 3, 4 and 5 as below. However, NAAS rating for additional publications (other than one allowed with NAAS rating 5.00 or above) or all the five publications must be 7.00 or above and Impact Factor (Thomson Reuters) 1.00 or above for basics science and other concerned disciplines, where NAAS ratings is not available.
- 3. The upper ceiling of such expenditure will be Rs. 20,000/- per year for plan schemes.
- 4. The expenditure may be sanctioned in DBT/DST/GOI/ICAR funded project, if there is a provision for publication expense in such project grants.
- 5. If saving is available at the end of completion of private company projects, University may permit for the said expenditure.
