Sub: Revised rates of emoluments for Senior Research Fellow (SRF) and Research Associates (RA) working in the ICAR funded schemes-reg.


Reference is invited to ICAR Office Memorandum No. 15(I)/2010-A&P (Edn.) dated 26th October, 2010, vide which emoluments payable to SRF and RA working in the ICAR funded schemes under operation in various host institutions were notified. The matter has been further considered by the Council and it has been decided to revise these emoluments as under:

A. Senior Research Fellows working in Research Schemes funded by ICAR			
Sl. No.	Category	Existing Rates	Revised Rates
1.	Post Graduate in subjects other than Veterinary Science	Rs. 16,000/-per month for 1 st and 2 nd year Rs. 18,000/-per month for 3 rd year	Rs. 25,000/Per month for 1 st and 2 nd year Rs. 28,000/- per month for 3 rd year
2.	Post Graduate in Veterinary Science	Rs. 18,000/-per month for 1 st and 2 nd year Rs. 20,000/-per month for 3 rd year	
B. Research Associates working in Research Schemes funded by ICAR			
3.	Master Degree Holders	Rs. 23,000/-per month	Rs. 38,000 per month
4.	Doctoral Degree Holders	Rs. 24,000/-per month	Rs. 40,000 per month

The other terms and conditions in the guidelines for SRFs & RAs working in ICAR Schemes shall remain the same as notified vide F.No. 2-9/2012-HRD dated 25th April, 2014.

The revised rates will be effective from 01.10.2014. The additional expenditure on this account will be met from the sanctioned budget grant of the respective schemes. This has the concurrence of MoF (DuE) vide their ID No. 96852/E.III(A)/2015 dated June 15, 2015 and IFD, ICAR vide e-office Dy No. 7460/2015.
