

Sub: Inviting concept note for the vacant positions of ICAR National Fellows in the areas of cutting edge technologies in agriculture and allied sciences

Dear Sir,

We are pleased to inform you that the ICAR proposes to fill-up the six vacant positions of ICAR National Fellows in the field of agriculture and allied sciences. The scheme of ICAR National Fellows is aimed at developing strong centers of research and education around outstanding scientists of proven competence and leadership.

These positions are equivalent to the position of a Professor/Principal Scientist in ICAR-Agricultural University system in the Pay Band-IV of ₹ 37,400 – 67,000 with Research Grade Pay of ₹10,000/- per month or as applicable/revised from time to time. In addition, the contingent funds for required staff, equipment and operational assistance would also be provided by the ICAR through the institution where the scientist takes up the research work. ICAR National Fellow will be appointed for an initial tenure of five years.

As per the guidelines for ICAR National Fellowship, a two-step process for inviting nominations is being followed, (a) Call for concept note about the proposed research programme from the eligible candidates and (b) Call for detailed project proposal from the shortlisted candidates based on the merit of the concept note. Accordingly, the concept notes are initially invited from Associate Professors/Senior Scientists/Research scientists in equivalent positions, active in research, minimum academics and experience of 10 years, out of which three years should be in the capacity of Senior Scientist/Associate Professor, and age not exceeding 45 years as on 15th May, 2013. The applicant should have demonstrated excellence through individual contributions and achievements in basic research in agriculture and allied sciences including veterinary science as evidenced by published work in NAAS rated journals, product/process/methodology, released and notified variety/breed/stocks, innovations as patents/protections etc. (visit ICAR Website: <http://www.icar.org.in/> for Guidelines of ICAR National Fellowships).

I take this opportunity to request you to give a wide publicity to this notice and encourage your scientists to submit the Concept note **through proper channel** as per the enclosed format (**Annexure-I**). The concept note must reach to the undersigned **latest by 15th May, 2013**. It may please be noted that canvassing of any kind will be treated as disqualification.
