No.(GN-23) No.PSN—102014-M1(334385)-P:-In Exercise of the powers conferred by the proviso to the article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Gujarat Civil Services (Leave) Rules, 2002, namely:-

- 1. These rules may be called the Gujarat Civil Services (Leave) (Second Amendment) Rules, 2014.
- 2. In the Gujarat Civil Services (Leave) Rules, 2002, in rule 69, in sub-rule (1):-
- (i) for the words "one hundred and thirty five days", the words "one hundred and eighty days" shall be substituted;
- (ii) to sub-rule (1), the following proviso shall be added, namely:-

"Provided that the provisions of sub-rule (1) above shall also be applicable in cases of those female employees who have been on maternity leave as on 1st October, 2014 or thereafter, but they shall not be entitled to such leave for more than one hundred and eighty days in aggregate."
