- Sub : Memorandum of Understanding (MoU) signed/to be signed with other countries – matters to be brought for consideration before the Cabinet – regarding.
- Ref : Letter from Under Secretary to the Government of India, Ministry of Agriculture, Department of Agricultural & Research Education (DARE), Krishi Bhavan, New Delhi, dt:5th June, 2015.

As per the referred letter, in view of the clear instructions of the Cabinet Secretariat, all agriculture universities (SAUs and Deemed Universities of ICAR) are requested to send all such draft MoUs to DARE for processing the same as per the prescribed guidelines of GoI on such matters. Care should be taken that no MoU with any foreign agency or country is concluded without obtaining clearance from DARE, New Delhi.

In this regard, all the University Officers, Deans, Principals, Unit /Sub Unit Heads, Faculty and Scientists are informed to take note that:

1. No agreement / MoU with any foreign or International organization should be signed nor even organise international conferences, without the approval of DARE, GoI, New Delhi.
2. In cases, such agreement/MoUs have already been done, they should not be acted upon and should either be ended, or got regularized by getting permission of DARE.
3. In future, whenever there is doubt about how an agricultural university should deal with foreign countries or organizations, it is best to refer the matter to DARE seeking clarification from them.
