

RESOLUTION

The question of revising the rates of Special Pay (Charge Allowance) in the light of introduction of revised pay structure under the Gujarat Civil Services (Revision of Pay) Rules, 2009 has been considered and Government is pleased to fix the rates of Special Pay (Charge Allowance) as under :-

- (1) Special pay at the rate of 5% of his/her basic pay for holding additional charge of another post of equivalent rank in the same Office or Department or in another Office or Department, and
- (2) Special pay at the rate of 10% of his/her basic pay for holding additional charge of another post which is next higher in rank in the same Office or Department or in another Office or Department is granted to State Government employees/officers.
2. Basic Pay in the revised pay structure means the pay drawn in the prescribed pay-band plus the applicable grade-pay, but does not include any other type of pay such as special pay, etc. specified in the Annexure to GR.FD.No. PGR/1009/1/Pay Cell(M), Dt. 12/2/2009.
3. These orders will come into force from 1-10-2012
4. The existing conditions governing grant of Special pay (Charge Allowance) will continue to remain in force.
