Sub: Nominations for the appointment of a regular Vice-Chancellor of Agriculture University, Kota, Rajasthan.

Sir,

With reference to subject cited above, you are requested to kindly nominate suitable person/s to be considered from amongst the eligible ones for appointment as a regular Vice-Chancellor of Agriculture University, Kota, Rajasthan, at the earliest.

Eligibility:

1. A person who has attained academic excellence and demonstrated leadership qualities in agriculture education and has minimum qualifications that is to say at least six years' experience on the post of Professor or equivalent in teaching or research or extension system of agriculture of any university or research centre in the country, out of which at least three years of experience should be as Dean of the Faculty of any agriculture university or Principal or Dean of any agriculture college or Director as defined in clause (k) of section 2.
- (k) "Director" means Director of Prioritization, Monitoring and Evaluation, Director of Research, Director of Extension Education, Director of Human Resources Development, Director of Students Welfare and other Directors of specified areas, which the University may create from time to time.
2. The term of the office of the Vice-Chancellor shall be three years from the date on which he enters upon his office or until he attains the age of seventy years, whichever is earlier.

The search and selection committee is shortly going to meet to assess different Bio-data, likely in the end of August, 2015, when final decisions shall be taken to submit a panel of names to His Excellency the Governor & Chancellor for consideration of the appointment to the position of Vice-Chancellor of Agriculture University, Kota.
