

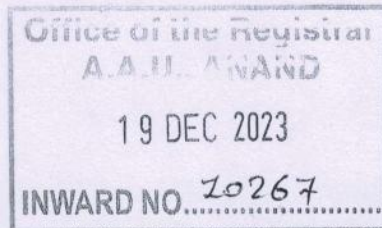

OFFICE MEMORANDUM

The existing guidelines for engagement of Young Professionals (YPs) on short-term basis were issued vide council's OM No. Ag. Edn.1-06/2020-A&P dated 04.12.2020. As per the guidelines, the remunerations of YP-I and YP-II were Rs.25,000/- and Rs.35,000/- (fixed) respectively. The existing remunerations of YPs have been reviewed by the competent authority in the Council. The Competent Authority, in partial modification of the Council's guidelines dated 04.12.2020 has enhanced/revised the existing remunerations of YPs as under:

S. No.	Level of YP	Existing Remuneration	Revised Remuneration
1.	Young Professional (YP)-I	Rs.25,000/- per month (Fixed)	Rs.30,000/-per Month (Fixed)
2.	Young Professional (YP)-II	Rs.35,000/- per month (Fixed)	Rs.42,000/-per Month (Fixed)

The revised remunerations will be effective from the date of issue of this OM for all YPs engaged/ to be engaged in the ICAR system. Other terms and conditions will be the same as stipulated in the Office Memorandum dated 04.12.2020.
