Start-ups in an economy's technology sectors are an important indicator of Technological performance for several reasons: first, the formation of new firms that focus on the development and introduction of new technology is a major source of innovation and technological advance. Many of these start-ups transfer new knowledge or new ideas into products and processes into commercial applications. Start-ups are likely to bring in new solutions and challenge established by individuals/companies that enter these new markets.

As per the provisions of GR Read above, State Level Implementation Committee in its 4th SLIC meeting held on date 17/05/2016 has sanctioned Anand Agricultural University, Anand as Nodal Institute. Brief details of facilities available at the institute are as under.

- 1 Separate seating arrangement for 20 persons
- 2 Minimum Area of 2500 Square feet
- 3 Incubation centre available 16 hours per day including post office-hours
- 4 Meeting room, Seminar/AV Conference hall, Computers, Internet Network
- 5 Concerned Subject experts

This sanction is subject to fulfillment of the following terms and conditions.

- a) The Nodal Institute has to invite and motivate the innovators for innovation
- b) The Nodal Institute has to give mentor services as well as has to allow innovators to utilize facilities available in the institute.
- c) The Nodal Institute has to appoint two full-time managers in the incubation. The manager should be certified for Research/Innovation guidance or they have to obtain it within the one year period.
- d) The Nodal Institute has to maintain records for all the expenditures and has to present it at the time of availing incentive. Subject to AG Audit.
- e) The institute has to observe pollution control measures as prescribed by GPCB or other competent authority whenever required.

- f) The Nodal Institute have to form a screening committee to select new potential ideas/start-ups on their level, the institute have to send the list of the members of the screening committee. The screening committee have to forward the details of the innovative project with their recommendations
- g) The Nodal Institute also have to mention on their official website and all correspondence related to the startup that now, they are approved as the Nodal Institute by the Government of Gujarat under the Start Ups/ Innovation Scheme.
- h) The Nodal Institute has to keep a **Separate Bank Account**, which should be used only for the Start-up/Innovation grants issued by Industries Commissionerate.
- i) The Nodal Institute has to register their Incubation Centre under Companies Act 1956, as a **Non Profit Organization** and registration copy should be submitted to Industries Commissionerate.
- j) The Nodal Institute should have **minimum 3 Innovative projects** under the incubation centre to become eligible for receiving grant under Start Ups/ Innovation Scheme.

Where in **Rs. 2,40,000.00 [Rupees Two Lakh Forty Thousand Only]** as sustenance allowance and **Rs. 17,00,000.00 [Rupees Seventeen Lakh Only]** as product development assistance for the project named **R.V Engineering Company (Rs. 10,00,000.00)** and **Food and Life Pvt Ltd (Rs. 7,00,000.00)** for the cost of raw-material, components and other related equipment for the project. As per GR referred, (2) Administrative approval for the year 2018-19 has been accorded by I & M Department vide above referred order at (3) and the grant is made available vide letter referred (4) at above.

The said amount shall be drawn met from the sanctioned grant for the year 2018-19. The grant is subject to the conditions as stipulated below: -

- a) The Nodal Institute should follow all the prescribed conditions jointly and cumulatively as mentioned in Sanction Letter from its inception to end.
- b) The Nodal Institute should maintain records for all the expenditures and has to present it at the time of availing incentive. Subject to AG Audit.
- c) The Nodal Institute should maintain the records in detail for all the expenditures incurred and has to submit the same before Industries Commissionerate, Gandhinagar.
- d) The Nodal Institute should mention on their official website and all correspondence related to the start-up that now, they are approved as the Nodal Institute by the Government of Gujarat under the Start Ups/ Innovation Scheme.
- e) The Nodal Institute will keep a separate Bank Account, which should be used only for the Start-up/Innovation grants issued by Industries Commissionerate.

- f) The Nodal Institute will get it registered their Incubation Centre under Companies Act 1956, as a Non-Profit Organization and registration copy should be submitted to Industries Commissionerate.
