Important Instructions for Screening Test:

- 1. The computer based screening test will consist of 60 multiple choice questions (each question carries 01 mark) from concerned discipline. The duration for the screening test will be 60 minutes. There will be no negative marking for wrong answer. The marks obtained in this test will not be counted in merit list.
- 2. Candidates are advised to remain present **30** minutes prior to the scheduled time. You have to come at your own expenses for screening test, University will not bear any expense for this purpose.
- 3. Candidates should bring any one of following photo identity proof such as driving license, passport, election voter card, Aadhar card, pan card with photo etc. If you fail to bring such photo identity proof, you will not be allowed to appear for the said screening test.
- 4. Mobile and any Electronic devices are strictly not allowed in Screening Test Lab. Any candidate found using such devices or indulging in other malpractices during the exam will be barred from the screening test.
- 5. Candidates are advised not to carry any valuables items with them. No facility will be available at screening test computer lab for safekeeping of such valuables. University/ test center will not be liable for any loss of valuables that the candidates bring along with them.
- 6. Based on the result of the screening test, candidates will be shortlisted in each category for personal interview. The result of said test / examination will be displayed before the scheduled time of personal interviews on notice board of University Bhavan on the same day. The shortlisted candidates have to face oral interview as per interview schedule placed on website: www.aau.in.
- The shortlisted candidates will have to produce all original documents pertaining to educational qualification, experience, NOC from the present employer in case in-service candidates SC/ST/SEBC/EWS categories certificates, Physically challenged certificate in case of PwD candidates, NET passing certificate, re-prints of research publications and other related documents in support to the candidature for the said post at the time of personal interview, failing which his/her candidature is liable to be rejected. In case of SEBC candidate from Gujarat State, original "Non-Creamy-Layer Certificate" issued by the competent authority on or after 01/04/2022 must also be produced at the time of interview for verification. In case of EWS candidate from Gujarat State, original "Economical Weaker Section Certificate" issued by the competent authority on or after 20/01/2022 must also be produced at the time of interview for verification.
- 8. The candidate has to come with 8 to 10 minutes prepared presentation on the topic of his her choice related to the discipline. The facility for presentation will be available during the interview. Only 8 to 10 slides should be brought in pen drive.
- 9. The actual selection of candidates will be based on the marks obtained in bio-data and the personal interview only. All the rights to change the date, time of screening test/personal interview as well as declaration of results shall be vested to the university authority.
